

**WINN-DIXIE - FLORIDA
TICKET TO THE GAME
OFFICIAL RULES**

OPEN TO WINN-DIXIE SHOPPERS WHO ARE 18 YEARS OF AGE OR OLDER.
VOID OUTSIDE OF FLORIDA AND WHERE PROHIBITED BY LAW.

1. HERE'S HOW TO PARTICIPATE IN THE WINN-DIXIE TICKET TO THE GAME promotion ("Promotion") beginning at 12:01 AM Eastern Standard Time ("EST") March 5, 2018 and ending at 11:59 PM EST May 19, 2018 or when all available tickets have been distributed, whichever comes first ("Promotion Period"):

ELECTRONIC ENTRY: You will be eligible to receive TWO free general admission tickets to your choice of one of the following: (1) a University of Florida baseball game; (2) a Florida State University baseball game; with a qualifying purchase of \$40 or more in a single transaction when you scan your registered WINN-DIXIE REWARD CARD with Plenti® with magnetic stripe and/or its associated key fob at any participating WINN-DIXIE Store during the Promotion Period. Your receipt will acknowledge eligibility for promotion at time of purchase and provide instructions for redemption. The list of participating stores will be posted at www.Winn-Dixie.com/TicketToTheGame during the Promotion Period. Tickets are limited and particular game tickets are available for selection while supplies last.

If you do not have a WINN-DIXIE REWARD CARD with Plenti®, you may apply for a free one at the Customer Service Desk at any WINN-DIXIE Store location. No purchase is necessary to obtain a card.
