# SEG GROCERIES SWEEPSTAKES

## OFFICIAL RULES

### NO PURCHASE NECESSARY TO ENTER, WIN, OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.

The SEG Groceries Sweepstakes ("Sweepstakes") is sponsored by BI-LO, LLC ("Sponsor"), 8928 Prominence Parkway, Building 200, Jacksonville, Florida 32256.

- 1. SWEEPSTAKES PERIOD: The Sweepstakes begins on January 9, 2019 at 12:00 AM Eastern Time ("ET") and ends on February 5, 2019 at 11:59:59 PM ET ("Sweepstakes Period"). The Administrator's computer is the Sweepstakes official clock.
- 2. ELIGIBILITY: This Sweepstakes is offered only to legal U.S. residents of Alabama, Florida, Georgia, Louisiana, Mississippi, North Carolina, and South Carolina who are at least eighteen (18) years old at the time of entry. Must be an SE Grocers rewards Card member to enter, win, or claim a prize. To become an SE Grocers Rewards Card member, visit www.SEGrewards.com. There is no cost to become a SE Grocers reward Card member. Employees, directors, officers, and agents of Sponsor, third party administrator ("Administrator"), and each of their respective parent companies, divisions, dealers, affiliates, subsidiaries, distributors, advertising and promotional agencies and suppliers involved in the Sweepstakes ("Sweepstakes Entities"), as well as the members of each of their immediate families (spouse, parents, children, siblings, and in-laws) and persons residing in the same household as such individuals are not eligible to enter or win. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

Participation constitutes entrant's full and unconditional agreement to these Official Rules and to Sponsor's decisions and interpretations, which are final and binding in all matters related to the Sweepstakes.

#### 3. HOW TO ENTER THE SWEEPSTAKES: There are two (2) ways to enter the Sweepstakes:

- A. Purchase Method of Entry: During the Sweepstakes period, an entrant may purchase three (3) anv qualifying products (each a "Qualifying Product") (see www.winndixie.com/freegroceries. www.bi-lo.com/freegroceries. www.harveyssupermarket.com/freegroceries, or www.frescoymas.com/freegroceries for list of Qualifying Products) in one (1) transaction with his/her participating SE Grocers reward Card at a participating BI-LO, Fresco, Más, Harveys Supermarket, or Winn-Dixie location ("Qualifying Purchase"). For each Qualifying Purchase (three [3] Qualifying Products), an entrant will receive one (1) entry into the Sweepstakes. Limit: Ten (10) entries per transaction and ten (10) entries per day. All Qualifying Purchases must be completed by 11:59:59 PM ET on February 5, 2019. Entrant must have a valid e-mail address associated with his/her SE Grocers reward Card.
- B. <u>Mail-In Method of Entry (No purchase required)</u>: To enter without a purchase, an eligible entrant may hand-write his/her complete name (no initials), valid e-mail address, street address (P.O. Boxes not accepted), city, state, ZIP code, telephone number, SE Grocers reward number, and date of birth (MWDD/YYYY) on a 3½"x5" card ("Mail-In Entry") and mail it with sufficient postage to: The SEG Groceries Sweepstakes, P.O. Box 251328, West Bloomfield, MI 48325. All Mail-In Entries must be post marked by February 5, 2019

and received by February 12, 2019 in order to be eligible. Each Mail-In Entry will earn an entrant one (1) entries. Limit: Entrant can send ten (10) Mail-In Entries per day (an entrant may send twenty [20] Mail-In Entries each Monday during the Sweepstakes Period).

**Entry Limit**: Regardless of the method of entry, there is a limit of ten (10) entries per person per day. If more than ten (10) entries are received from the same person, telephone number, loyalty card, and/or e-mail address in a single day, only the first ten (10) entries received may be considered valid. If an entrant attempts or is suspected of attempting to receive more entries than is permitted, Sponsor may, at its sole discretion, disqualify such entrant.

4. RANDOM DRAWING: On or about February 13, 2019, Administrator will randomly select ten (10) potential grand prize winners and one thousand two hundred (1,200) potential first prize winners from all eligible entries received ("Random Drawing"), provided a sufficient number of entries are received. Each winner is considered a potential winner pending verification of his/her eligibility and compliance with these Official Rules.

## 5. PRIZES, APPROXIMATE RETAIL VALUES, AND ODDS OF WINNING:

- A. Grand Prizes (10): Each grand prize winner will receive "groceries for a year," awarded as fifty-two (52) \$100 gift cards to Sponsor's stores ("Grand Prize"). The use of a gift card is subject to the terms and conditions set forth thereon which shall govern the use of the gift card. Use of a gift card constitutes the user's acceptance of the terms and conditions so a winner should read the terms and conditions on a gift card carefully. A winner must protect a gift card and treat the gift card as he/she would any other valuable document. A gift card will not be redeemed or exchanged for cash, except where required by law. A gift card will not be replaced or replenished if it lost, stolen, damaged, destroyed, or used without a winner's permission and will be voided if altered or defaced. Ten (10) Grand Prizes will be available in the Sweepstakes. The approximate retail value ("ARV") of each Grand Prize is \$5,200.
- B. First Prizes (1,200): Each first prize winner will receive one (1) voucher per week for fiftytwo (52) weeks; each voucher is redeemable for a product to be determined by Sponsor, in its sole discretion ("First Prize"). See the Appendix to these Official Rules for products that may be included in First Prize vouchers; note that the product list is subject to change based on availability and in Sponsor's sole discretion. One thousand two hundred (1,200) First Prizes will be available in the Sweepstakes. The ARV of each First Prize is \$156 (the ARV of each redeemable product will be \$3).
- C. Total ARV: The total ARV of all Prizes available in this Sweepstakes is \$239,200.
- **D. Odds of Winning:** The odds of winning a Grand Prize or First Prize (each, a "Prize") depend on the total number of eligible entries received during the Sweepstakes Period.
- E. General: In no event will more than the above quantities of Prizes be awarded. If, for any reason, more Prize notifications are sent (or more claims are received) than the number of Prizes offered, as set forth in these Official Rules, Sponsor reserves the right to award the intended number of Prizes through a random drawing from among all eligible Prize claims received. There is a limit of one (1) Prize per person.

Administrator will attempt to notify each potential winner by telephone or e-mail after the Random Drawing with instructions on how to claim his/her Prize. A potential winner must reply to the notification within ten (10) calendar days and provide all requested information, or the Prize may be forfeited and awarded to an alternate potential winner, at Sponsor's discretion. Each potential Grand Prize winner will be required to sign and return an Affidavit of Eligibility and Liability/Publicity Release (except where prohibited) and any other requested documents within ten (10) calendar days from the date of attempted notification or the Grand Prize may be forfeited in its entirety and awarded to an alternate winner, at the Sponsor's sole and absolute discretion. Upon verification of eligibility, each Grand Prize will be mailed to a Grand Prize at the Grand Prize winner's address associated with his/her SE Grocers rewards Card account and First Prize vouchers will be uploaded to First Prize winners' reward cards weekly. The Sweepstakes Entities shall not be held responsible for any delays in awarding a Prize for any reason. If a potential winner is found to be ineligible, is not in compliance with these Official Rules, declines to accept a Prize, or any winner notification is returned as undeliverable or a potential winner fails to respond to a winner notification within the timeframe specified in such winner notification, or if a potential winner does not answer the initial telephone notification, the respective Prize may be forfeited. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN DUVAL COUNTY, FLORIDA. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES. AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE. EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING BUT NOT LIMITED TO ATTORNEYS' FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF.
