## SE GROCERIES FOR A YEAR SWEEPSTAKES OFFICIAL RULES

## NO PURCHASE NECESSARY TO ENTER, WIN, OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.

The SE Groceries For A Year Sweepstakes ("<u>Sweepstakes</u>") is sponsored by BI-LO, LLC ("<u>Sponsor</u>"), 8928 Prominence Parkway, Building 200, Jacksonville, Florida 32256.

- 1. SWEEPSTAKES PERIOD: The Sweepstakes begins on July 24, 2019 at 12:00 AM Eastern Time ("ET") and ends on August 20, 2019 at 11:59:59 PM ET ("Sweepstakes Period"). The Administrator's computer is the Sweepstakes official clock.
- 2. ELIGIBILITY: This Sweepstakes is offered only to legal U.S. residents of Alabama, Florida, Georgia, Louisiana, Mississippi, North Carolina, and South Carolina who are at least eighteen (18) years old at the time of entry. Must be an SE Grocers Rewards member to enter, win, or claim a prize. To become an SE Grocers Rewards member, visit www.SEGrewards.com. There is no cost to become a SE Grocers Reward member. Employees, directors, officers, and agents of Sponsor, third party administrator ("Administrator"), and each of their respective parent companies, divisions, dealers, affiliates, subsidiaries, distributors, advertising and promotional agencies and suppliers involved in the Sweepstakes (collectively, the "Sweepstakes Entities"), as well as the members of each of their immediate families (spouse, parents, children, siblings, and in-laws) and persons residing in the same household as such individuals are not eligible to enter or win. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

Participation constitutes entrant's full and unconditional agreement to these Official Rules and to Sponsor's decisions and interpretations, which are final and binding in all matters related to the Sweepstakes.

Note: products are subject to availability and may change, at Sponsor's sole discretion) in one (1) transaction with his/her participating SE Grocers reward Card at a participating BI-LO, Fresco, Más, Harveys Supermarket, or Winn-Dixie location ("<u>Qualifying Purchase</u>"). For each Qualifying Purchase (three [3] Qualifying Products), an entrant will receive one (1) entry into the Sweepstakes. Limit: Ten (10) entries per transaction and ten (10) entries per day. All Qualifying Purchases must be completed by 11:59:59 PM ET on August 20, 2019. Entrant must have a valid e-mail address associated with his/her SE Grocers reward card.
  - B. <u>Mail-In Method of Entry (No purchase required)</u>: To enter without a purchase, an eligible entrant may hand-write his/her complete name (no initials), valid e-mail address and/or telephone number, street address (P.O. Boxes not accepted), city, state, ZIP code, SE Grocers reward number, and date of birth (MM/DD/YYYY) on a 3½"x5" card ("<u>Mail-In Entry</u>") and mail it with sufficient postage to: The SE Groceries For A Year Sweepstakes, P.O. by August 20, 2019 and received by August 30, 2019 in order to be eligible. Each Mail-In Entry will earn an entrant one (1) entry. Limit: Entrant can send ten (10) Mail-In Entries per day.

**Entry Limit**: Regardless of the method of entry, there is a limit of ten (10) entries per person per day. If more than ten (10) entries are received from the same person, telephone number, loyalty card, and/or e-mail address in a single day, only the first ten (10) entries received may be considered valid. If an entrant attempts or is suspected of attempting to receive more entries than is permitted, Sponsor may, at its sole discretion, disqualify such entrant.

4. RANDOM DRAWING: On or about September 3, 2019, Administrator will randomly select ten (10) potential grand prize winners and seven hundred (700) potential first prize winners from all eligible entries received ("<u>Random Drawing</u>"), provided a sufficient number of entries are received. Each winner is considered a potential winner pending verification of his/her eligibility and compliance with these Official Rules.

## 5. PRIZES, APPROXIMATE RETAIL VALUES, AND ODDS OF WINNING:

- A. Grand Prizes (10): Each grand prize winner will receive "groceries for a year," awarded as fifty-two (52) \$100 gift cards to Sponsor's stores ("Grand Prize"). The use of a gift card is subject to the terms and conditions set forth thereon which shall govern the use of the gift card. Use of a gift card constitutes the user's acceptance of the terms and conditions so a winner should read the terms and conditions on a gift card carefully. Coupons will be available in winner's digital coupon gallery (accessible via desktop and app) and winner must activate each weekly coupon in order to use it. Seven hundred (700) First Prizes will be available in the Sweepstakes. The ARV of each First Prize is \$156 (the ARV of each redeemable product will be \$3).
- **C. Total ARV:** The total ARV of all Prizes available in this Sweepstakes is \$161,200.

CONSEQUENTIAL OR INCIDENTAL DAMAGES OR HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING BUT NOT LIMITED TO ATTORNEYS' FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF.
